- 2) Minutes

The Chairman was authorised to sign the minutes of the Parish Council meeting held on January 19th as a true record of that meeting.

- 3) Members to declare any interests they may have in any item on the agenda. (None)
- 4) Adjournment of meeting: The Chairman will adjourn the meeting to allow parishioners an opportunity to ask questions and raise matters of interest. There were no matters raised.
- 5) Maintenance and Matters of Report
 - a) Police Matters: Apologies for not attending. There had been no incidents in the parish recently.
 - b) Seating area at the top of the hill: Work would start soon subject to the weather. The new seat would be part of the wall.
 - c) Low Farm: Work is under way and there is a meeting planned for the 17th March 2009.
 - d) Highway Stewards: Matters for: Isel Hall to Almshouses road edges; Parkwood road and the back lonning. It was agreed to send a general letter to the Highways Dept re the state of the roads in the parish and that gulleys are not being emptied when the gulley emptier comes round.
 - e) Drainage on the Village Green: This was being closely monitored.
 - f) White barn at Skiddaw View Farm, Setmurthy: The NPA have an open enforcement case on this.
 - g) Grass cutting contract for 2009: There were six applications and it was agreed to award it to the existing contractor, HGP (Prop: JT; Sec: LW, Passed unanimously.)
 - k) Website This was now live. Excellent site thanks to Keith Snell.
 - l) Gritting of roads in the parish in adverse weather: Some grit piles had been put out. These would be restocked on September
 - m) New seat on the green: This was now in place and brackets were being made to attach it to the ground.
 - n) Cleaning out of ghyll: This had been poorly done by 3 men from the Environment Agency with a strimmer and a spade. They had also left all the cuttings etc on the verge. The ditch really needs deepening to carry away more water in heavy rain. Rachel Gerrard offered to chase this up.

- p) Light at Home Farm: ABC had no knowledge of this former light. The Rose farm light was still on.
- q) Bend signs at Longclose: The Highway Steward would be asked to look at it.

- r) Village sign on the ghyll road: John Thompson was looking for funding for this and also two signs for Sunderland. One Blindcrake sign would cost £500 and three for Sunderland would cost £1250, but there would be a discount for all four. It was agreed to apply for grant funding and also ask for suggestions for future projects in the Newsletter.
- s) Footpath restoration in the parish: There is money and support available to restore footpaths in the parish, some of which are in a poor condition. Can we get the county footpath officer to attend a future meeting?
- t) Village Hall appointees: It was agreed to re-appoint Hilton Brough and David Roberts.
- u) Reclaiming VAT: it was agreed to look at reclaiming VAT from past years.
